August 2, 1954. Contacted Mrs. Opal Davis of 375 Kenilworth, Bay Village, Ohio re one Louis France of 28628 Lake Rd., Bay Village;

Mrs. Davis gave quite a run down on this man who has been in difficulty with the United States Government on several occasions, who has mental trouble and financial trouble. Details of all this are not enumerated as Sherriff Carl Rossbach interviewed this woman early in the case. This man killed in auto accident Aug. 1, 1954.

Contacted Loudenville, Ohio, Banks Funeral Home, and asked them if there local police could get a palm print of this man. Mr. Banks was to let me know if they could do this and if not was going to make arrangement for us to meet him at the Hillcrest Cemetary for this purpose.

Have heard nothing from Banks on this matter as yet.

Mrs. Davis was quite concerned about this man as he lived just two houses away from the Sheppards and he had tried to commit suicide and Dr. Sheppard had saved his life and he resented being saved.
