When the idea was new, the attendance at the lectures was admirable. As the series progressed, the attendance declined. It did not improve at the DiSalle lecture. Here was a man that is known to all of us, in fact, to most of the country, speaking to our own students and faculty, at our school. The response was appalling, particularly in the spacious new facility.

Classes were adjourned early, not so people could go home to bed, or to watch television, or to stop at the local pub since the wife was not expecting the breadwinner home for another hour. No, classes were adjourned early so that the speaker WOULD HAVE AN AUDIENCE.

The student body was not alone remiss. The vast majority of the factulty was very conspicuous by its absence. The very same indictment applies equally to both teacher and student

It matters not what the politics of the absentees might be. To show common courtesy to a guest, yes, an invited guest, is the only point at issue here. The host does not invite someone to his house, then depart himself at the appointed hour. Or are there new rules now governing social events, now?

Comments were made by responsible Council officers that "This is it, as far as we are concerned." They cannot be blamed for this attitude.

If this school is to remain a small-time locally reputed law school, then so be it. If, on the other hand, it intends to add luster to its reputation, then all must work to that end, starting with the faculty.

A good place to begin is by supporting the lecture series. We have the series.

Let us not lose it by a lack of enthusiasm and support.

The nation's top authority on non-profit organizations, Howard L. Oleck, Associate Dean of Cleveland-Marshall Law School, has authored a new book on practice and procedure for such organizations, titled Non-Profit Corporations, Organizations, and Associations (2d edition) just published by Prentice-Hall Company.

The book, the only one on the subject, shows, step by step, how to start and operate a non-profit organization, including a club, library, credit union, fraternal order, foundation, chamber of commerce, "improve-your-city" committtee, and many others. It outlines the procedure for obtaining necessary licenses and authorizations. It discusses federal tax problems, covers property transfers, payments to officers, legal rights (Continued on Page 4)

## **Adds Memorial Gifts** The second phase of a four-year campaign to pay for the first-floor remodelling improvements at the Cleveland-Marshall Law School was kicked off last week with the mailing of a descriptive leaflet and pledge card to all alumni.

Second-Year Campaign

The leaflet shows the various improvements made recently at the school, in great measure as the result of the commitment of the C-M Alumni Association. The leaflet has also been mailed to all practicing attorneys in the Cleveland area to acquaint the profession with recent developments here.

Again, the goal of the Alumni Association's fund-raising campaign is \$20,000, which is the figure that was met last year with the help of existing funds from Alumni dues.

This year, it is the hope that the money can be raised without assistance from other Alumni Association funds. While the fund drive last year was strictly a mail campaign - and a very successful one according to veteran observers this year's campaign will involve the use of building canvass committees, by which all alumni with offices in a given building will be contacted by a committee of fellowalumni from that same building.

In addition, donors of substantial contributions, including those from last year, will have their gifts memorialized with a plaque in honor of a person of the donor's choosing, as a parent, other relative, associate, or friend.

A third element of this year's campaign will include approaching corporations and foundations, now that the Association has one year's experience behind it, and can show to such organizations the percentage of alumni contributing to their law school.

Sometime in January, the Trus-

tees of the Alumni Association will announce the name of fund drive chairman for the coming year, and it is expected that he will be an alumnus whose background and experience will help the Association in its bid for assistance from industry and the various founda-

# Ohio Unique in Prosecution Of Criminals: Saxbe Says

The Honorable William B. Saxbe, Ohio's Attorney General addressed Cleveland Marshall students, alumni and faculty on October 22nd. Primarily, he dealt with criminal law and expressed regret that more attorneys do not work in the field. Perhaps some of the idealism of earlier days has gone from the practice of law, he indicated.

Mr. Saxbe stated that Ohio is unique in its prosecution of criminals as there are no criminal courts higher than at the county level (Court of Common Pleas). Therefore, state law enforcement is difficult. A recent development, however, has improved the situation slightly for the State. Now a prisoner must begin a habeas corpus action in the court where he was originally convicted.

Commenting on the current criticism of U.S. Supreme Court decisions, Mr. Saxbe stated that this is the price we must pay to protect the Bill of Rights in our Federal Constitution. He added that our Constitution insures the dignity of the individual even though certain decisions appear to favor the "criminal."

In Mr. Saxbe's opinion, the plan for reapportionment submitted to the Federal Court is a fair one. It is based on guidelines from the court decision and is not a product of gerrymandering. He expressed doubt that the legislators themselves would have ever reached an equitable conclusion because of the reduction in the number of legislators required. Perhaps Ohio will lead the nation with a method of compliance under Supreme Court directions, he added.
