# More Than 1200 Alumni and Friends Gather to Laud Outstanding Alumnus

More than 1,200 Cleveland-Marshall Law School alumni and friends of U.S. District Judge James C. Connell gathered for a luncheon in the Grand Ballroom of the Sheraton-Cleveland Hotel on Tuesday, May 17 to honor the federal jurist as the law school's Outstanding Alumnus of the Year.

The award to Judge Connell, a 1918 graduate of the law school, was presented by Aaron Jacobson, president of the school's alumni association. Said Jacobson "Judge Connell's

contribution to his profession and to his community have been truly outstanding. We are proud to have him on the Alumni Association's Board of Trustees, and on the Board of Trustees of the law school as our representative."

On hand to honor the jurist were Mrs. Connell, and their son and daughter-in-law, Dr. and Mrs. Inomas Connell, and some of his old friends, including Leonard Levy, Warren Briggs, Michael Picciano, Judge James Cassidy, Dr. Sam Gerber, Al Anderson, Ricky Tanno, Sam Whitman, and Henry Williams. Judge Connell's colleagues on the federal bench also paid tribute to their fellow jurist. They included federal judges Girard E. Kalbfleisch, Frank J. Battisti, Ben C. Green, William K. Thomas, Anthony J. Celebrezze, and Paul E. Weick.

Wilson G. Stapleton, Dean of the law school, reported on the tremendous strides made by the law school in the past year, academically, administratively, and in its physical plant, as well.

#### Introduction by Howley

Master of Ceremonies for the event was James Vance ('60), assistant treasurer of Republic Steel Corporation.

Lee C. Howley, Cleveland Electric Illuminating Company official and old family friend of Judge Connell's, made the introduction, commenting on the judge's biographical data. He noted that his father and Judge Connell's father served together as officers in Cleveland's Fire Department.

Remarking on this fact, Judge Connell, in his speech, which followed, said "Those were happy days for them. After all, who could be happier than an Irishman with an axe in his hands?"

The answer at the moment was obvious: it could be an Irish judge — one of the profession's finest receiving a standing ovation and words of praise from the largest assemblage of lawyers and friends in the town's recent history.

# Association Presents \$10,000 To School From Development Fund

More than half a thousand C-M Alumni gathered Thursday afternoon, June 9, in the law school for the alumni association's Annual Party. Described as the biggest and best of any such event held to date, the affair drew alumni from as far away as Gary, Indiana.

The alumni in attendance included Federal Judge James C. Connell, recently honored by the Association as its Outstanding Alumnus of the Year, and a number of other jurists from the various courts in the area.

Once again, the Alumni Association used this occasion to present to the administration of the law school a contribution toward its pledge to help cover the construction cost of the impressive improvements on the building's first floor. This year, the Alumni Association was able to collect and hand over from its Development Fund the amount of \$10,000 (see picture on this page), with newlyelected alumni president Patrick G. Lazzaro making the presentation to Dean Wilson G. Stapleton and to Comptroller Sidney B. Fink.

Heading the committee for the event was Leo Rossmann, ('29), Treasurer of the Alumni Association and President of Certified Office & Supply Company. Tastee Catering served an excellent hot and cold buffet, while the charming accordianist Shirley Joyce wandered among the alumni, occasionally leading them in songs which she, at least, made recognizable despite efforts of the self-proclaimed choristers.

Starting at 4 p.m., the affair lasted until 8 p.m., when the last of the revellers was nudged out the
