

> "He was taken to the City Hall and behind locked doors, without benefit of counsel the attendance of his counsel being refused by the author-ities who had taken him into custody.

> "He was arraigned not before a magistrate but before a councilman.

## **Knocking** Ignored

"When we arrived at the police station we found it locked, our knocking at the door. We gandt, the village solicitor, whatever his first name is, the chief of police, the council-man who issued the warrant. They all refused to answer the telephone.
