# Corrigan Photos Evidence

During noon recess at the Sheppard trial today Defense Lawyer William S. Corrigan brought in his own photographer and started rummaging through the trial exhibits store in Bailiff Edgar Francis' closet.

Corrigan chased newspapermen away, but it was learned he had his cameraman copy

around in that time by state's witnesses, lawyers for both sides and Judge Edward Blythin.

Sanford Lester and Norman Stern, the court reporters, say they've had no trouble keeping their stenotype machines abreast court proceedings, but Lester admitted it was a little rough keeping up with Deputy Coroner Lester Adelson when he was testifying.
