Police Told: Stick to End Of Bay Quiz'

Threatened to Ouit Over Release of Doctor on Bail

The Cleveland Police Department today was ordered to continue investigation of the brutal Marilyn Sheppard murder and to "stick with it to the finish" as Safety Director John N. Mc-Cormick criticized police complaints on the release of Dr. Samuel Sheppard.

The order was issued by Mc-Cormick after police officials threatened to pull out of the case in protest against the release on bail of Dr. Sheppard, whom they view as the No. 1

suspect.

Celebrezze Comments

Mayor Celebrezze promptly seconded McCormick's order and stated that Cleveland police "will not be pulled out arbitrarily." The mayor asserted that many

of the detectives assigned to the case have completed their jobs and will be reassigned to regular duty, but "only because we have exhausted the leads up to this point."

"The release of Dr. Sheppard is not an obstacle to justice," Mayor Celebrezze said. "Al-

"We have reached the end of our investigation — that's all there's to it," Chief Story said. "We've run down every bit of
