Murder Rule Could Disinherit Sam

Dr. Sam Sheppard could not inherit his wife's estate if he is convicted of either first or second-degree murder.

This was made clear by Probate Judge Walter T. Kinder, despite the fact that Mrs. Marilyn Sheppard's will named her husband as beneficiary.

The will, dated Feb. 22, 1954, was filed yesterday and names her son, Chip, 6, as beneficiary if she was not survived by her husband.

Dr. Sam, who was named executor, declined to serve and Judge Kinder appointed his father, Dr. Richard A. Sheppard, to handle the estate.

If convicted of manslaughter, Dr. Sam would not be barred from inheriting the estate, which lists \$9100 in real estate and \$100 in personal property.

Hearing will start at 9:15 a. m. before Common Pleas Judge A. H. Blythin.

Davis is the 17-year-old who reported this week that he had chased a prowler from the bedroom at his home. Spawicki and the Knitters were said to have been driving past the Bay Village home of the Sheppards and seen a figure in the area.
