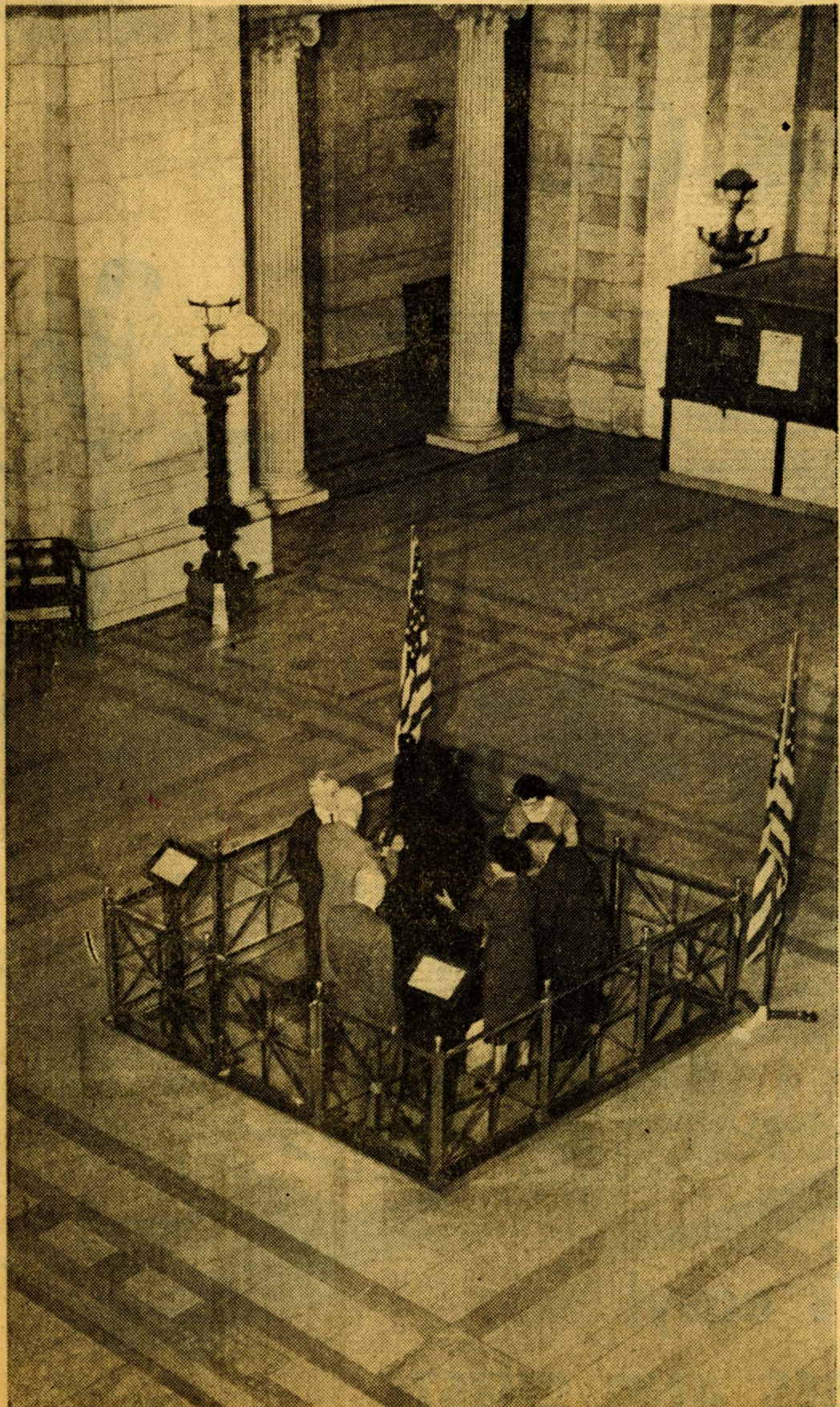

75 PICKED FOR SHEPPARD JURY

The mahogany-colored jury drum on a marble slab in the rotunda of Lakeside Courthouse today became a wheel of destiny in the life of Dr. Samuel H. Sheppard.

From it were drawn the names of 38 men and 37 women—the special venire of 75 prospective jurors for the case of “the People of Ohio vs. Samuel H. Sheppard.”

The jury list included two men named “John Smith,” two Bay Village women and the wife of a Cleveland detective Mrs. Ralph M. Imhof.

The persons whose names came up in the legal lottery will be notified within 48 hours that they are ordered to report to the Criminal Courts Bldg. on the morning of Oct. 18, when the 30-year-old osteopath comes to trial on an indictment charging him with

the premeditated July 4 murder of his wife, Marilyn.

Clifford A. Dunham, veteran of a dozen years as jury commissioner, whirled the teakwood drum, shuffling the 8000 slips of paper—each with the name and address of a prospective juror.

The names were taken from lists of registered voters. Each person entered in this draw had been questioned in 1952 and had indicated willingness and capability to serve on Cuyahoga County juries.

Common Pleas Judge Samuel H. Silbert stood by, supervising the process by which

a democracy selects the 12 “peers” who determine the facts when the state charges a crime and defendant denies it.

Dunham drew the 75 names from the 34-year-old drum in rapid succession.

He handed the slips to Miss Florence Slater, a deputy sheriff, who called out the number and passed them on to Leonard Fuerst, clerk of courts. Fuerst wrote the number on each slip, and handed it to Mrs. Helen Karpinsky, assistant jury commissioner.

A dozen spectators gathered and watched the brief drama, which took four minutes.

“That’s it,” said Dunham, and snapped the lock on the drum, flanked by American

flags and two small statues of the blindfolded goddess of justice.

Within a few hours, the list was made available to prosecution and defense attorneys.

Both plan a "thorough check"—without actual interviewing of the jurors—to determine their occupations, affiliations and possible opinions.

Defense Attorneys William J. Corrigan and Fred Garmone have announced they will demand that Dr. Sam's trial be moved to another county, claiming that public opinion here is "inflamed" against the Bay Village osteopath. But there are few precedents for such a change of venue being granted from a major metropolitan area.

The jurors will receive \$5 a day for the trial and the time devoted to jury selection. Those who live outside the city limits will get an additional 5 cents a mile allowance for travel to and from their homes and the Courthouse.

Some Exempt

Under Ohio law, the only citizens exempt from jury duty are schoolteachers, firemen, police officers, ministers, and — through a legal quirk — persons who make cash contributions to the Ohio National Guard.

When the jury selection begins, both prosecution and defense are each entitled to six "peremptory challenges." They are permitted unlimited challenges "for cause," with the presiding judge ruling on the motion.

Should the lawyers fail to seat 12 jurors and two alternates from the venire of 75, additional names can be drawn from the drum. The first dozen names drawn will be the people seated in the box when jury selection begins.
