EDITORS' PREFACE

The new *Cleveland State Law Review* cover, designed by nationally known artist Bernice Kochan, exemplifies one of the more visible recent changes in the *Review*. Because the *Review* has undergone many substantial changes in the past year (some obvious and some not so obvious) the Editors consider it appropriate to bring the more important ones to the attention of our readers.

The *Review* has adopted the traditional law review format which includes articles, notes, comments, case comments and book reviews. It should be emphasized that the new format was adopted solely to aid the researcher in determining the scope and authorship of the manuscript rather than to distinguish its quality. Also, the nomenclature designating issues is new, i.e. Winter, Spring and Fall rather than January, May, and September.

It is readily acknowledged that the worth of any law review is contingent upon its content. In this regard, "balance" has become the central theme behind much of what the Board is hoping to accomplish. The areas of major concern include: general (national and international) law versus Ohio law; theoretical exposition versus the practical ("how-to") application of the law; and non-student versus student contributions.

Organizationally speaking, the *Review* has adopted a new code. In April of this year, the Board will elect an Editor-in-Chief to serve an annual term. An executive committee composed of the Editor-in-Chief and three appointed Issue Editors will administer the *Review's* policy. Those aspiring to become Editors of the *Review* will now have to meet stricter requirements which include a grade average minimum, a candidacy of three quarters, and a written manuscript for the *Review* of the highest quality. Academic credit (pass-withdraw) for law review participants will be achieved only after successful completion of an additional three quarters as an Editor. Despite these stringent requirements, the Board is happy to announce that the *Review* is presently enjoying its greatest number of student participants ever.
