CLEVELAND-MARSHALL LAW SCHOOL

Baldwin University Law School, organized in 1897 and incorporated in 1899 under the name of The Cleveland Law School as the law department of Baldwin-Wallace College, and the John Marshall School of Law, established in 1916 and soon thereafter affiliated until 1924 with Ohio Northern University, were consolidated in 1946 under the name of the Cleveland-Marshall Law School.

Approved by the American Bar Association and the League of Ohio Law Schools, as well as by other accrediting agencies, Cleveland-Marshall Law School is a non-profit corporation dedicated to the preparation of men and women for the active practice of law in all common-law jurisdictions, and especially in Ohio, and to providing legal training for qualified persons who plan to enter public service, business, or other professions.

Housed in excellent quarters, ideally located in the heart of Cleveland, equipped with every modern facility for the study of law, staffed with full-time and part-time instructors drawn from the top ranks of the law teaching profession, the bench and the bar, this school has a tradition of scholarly practical training. Its alumni, occupying leading posts in every branch of American law, government, business and education, evidence the soundness of this tradition—the combination of theory with practice.

On this well-proven basis, the Trustees, Faculty, Staff and Alumni of Cleveland-Marshall Law School propose to continue to build.
