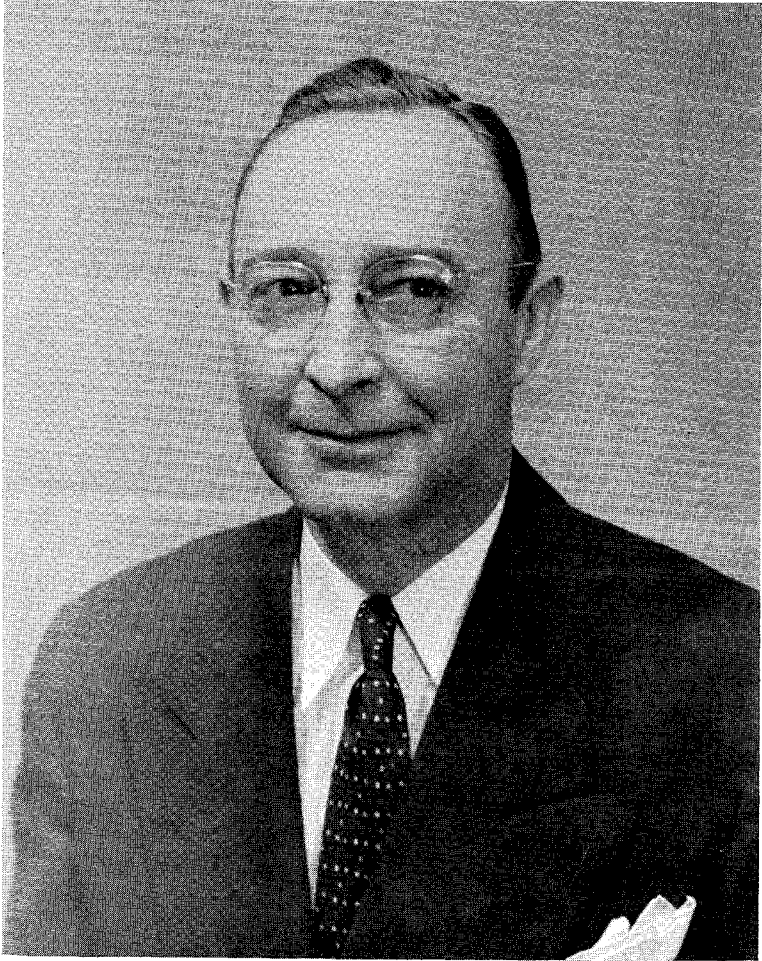

JUDGE DAVID C. MECK

Judge David C. Meck was born in Cleveland in 1905, the son of the late Judge David C. Meck and Dr. Gertrude K. Meck. He was educated in the Cleveland public schools, the Hackley School, Tarrytown, New York, Harvard College and Western Reserve University School of Law, from which he was graduated in 1930 as an honor student and member of the Order of the Coif. His scholastic career paralleled that of his parents, reflecting achievement at a superior level, and recognized by the award of the degree of Doctor of Laws by Wilberforce University in 1952.

Upon graduation from law school, Judge Meck engaged in the practice of law and in 1935 embarked upon what has since become an outstanding record of public service. He was assistant police prosecutor for the City of Cleveland from 1935 until 1938, assistant law director from 1938 to 1941, attorney for the Securities and Exchange Commission in 1942 and regional supervisor of the Federal Security Agency from 1942 until 1944. He was then elected judge of the Municipal Court of Cleveland where he still serves.

During his early tenure as municipal judge he was called to service and performed duty as consultant to the American Economic Mission in the Middle East under James M. Landis, former dean of the Harvard Law School. After performing his mission there he returned to the court from which he had been granted a leave of absence.

His father was one of the founders of the John Marshall School of Law and in 1930 the son commenced a career in legal education which was to follow that of his father. Serving on the faculty of the John Marshall School of Law from 1930 until 1939, he became dean in the latter year and guided the growth and progress of that school until it merged with the Cleveland Law School in 1946 to become the Cleveland-Marshall Law School. Since 1946 he has served as director of education of the successor school and as a member of the executive committee. Judge Meck has given his time and ability to the end that the Cleveland-Marshall Law School has become one of the leading law schools in the Country.

Factual details speak for themselves but no mere recitation of accomplishment can give a true picture of Judge Meck. Quiet and unassuming, he is blessed with the brilliance of mind, the humor, and the judicial temperament which have earned him not only the respect of those who present their causes in his court, but also the deep affection of his friends, his associates and his student body.
